Welcome - Call Meeting to Order - Approve Agenda - Approve Minutes

Treasurers' report: Received \$3,047.45 from Geocon event in La Crosse Wisconsin. All School money has been received and Simpson has been added back on the list. Mini grant of \$1,000 approved for

Mini Tree. Will have more to report over next few months. UNI GeoTree has been given the \$1,000 mini grant as well. Statewide license update: will be talking with Esri further in next couple months to go over new site license since they (Esri) are renovating the entire process. Josh Obrecht, Jon and Debbie had a call with Esri and they had a good discussion about changes. Things look good for future process.

IGIC/ICIT Joint Conference - Rick Havel spoke about the conference. Mick Macman is chairing and guiding the committee and so far communication has been good. They sent out a pre-conference survey and had 133 returned. At this point they are putting a lot of work into finalizing the Tuesday workshops for topics. One will be on Web App Builder including JavaScript. Another may be on Storymap development. A couple GIS and a couple of IT workshops are planned, five available slots. The conference agenda is coming together well. They are also working on registration and gifts. Programming is looking good. ?Mac? spoke on the team and stated things are going well. There are a few veterans on the crew as well as a few new folks. Joe Eckmann spoke about having the Esri hands on learning lab for the event. He is fairly confident it will be approved, but need to get through some more red tape before it is a go.

Committee Reports and Regional User Groups

GIS 911 Committee – Lawrence - They are in maintenance mode right now with geocom, receiving data on a regular basis and then pushing that through to the database. They also receive monthly reports and it seems as though the effort is progressing forward as planned.

Geodetic Committee - Lawrence - The group is brainstorming ideas on the statewide repository so that it could be a one stop shop for surveyors to see high accuracy monuments as well as PLSS corners. There are some hurdles to jump through like where it will be housed, and how to maintain data authoritativeness. They drafted a survey using surveymonkey and Adam C and Dave Croll will work with counties to complete these surveys to see what data they already have as far as monuments and then using that information make a plan for the next steps.

Outreach/Clearinghouse Committee – Casey Kohrt (DNR) and Patrick Wilke-Brown are deploying a Drupal/DKAN on Amazon Web Services, ETA is a couple of months out.

The boundary project has them working on state, county, and city boundaries, identifying authoritative sources and data processes, certifying agencies to determine who has the "official" boundary. Presentation

Iowa Geological Survey - Stephanie Surine shared information on the state map program of IGS. Bedrock and surficial mapping is being done. They use a lot of GIS data, all of it is available. She would like to get some feedback on the project, state pays for basic mapping and she would like to hear about what folks would like and find beneficial to be done.

USGS funded the program, with a 50/50 match between state and USGS. Submits proposals yearly for funds. Mix of university and academics, DOT, private consultants, etc. help decide critical issues in lowa to be mapped. If you have critical needs, they would like to hear from you. Partnerships built are bonus for the program.

Geologic Mapping in Iowa - http://ncgmp.usgs.gov/about/statemap.html

STATEMAP - State geologist determine mapping priorities in consultation with multi representational mapping advisory committee. One of the goals is to encourage further geological mapping. Program areas - mapping in developing areas, impaired watersheds, and cooperative mapping with NRCS.

One year funding cycle - FY16 due in November. Typically propose 2 or 3 projects each year to USGS July 1 to June 30 funding cycle. 2010 - bedrock map completed. Recently working on paired mapping with bedrock and surficial maps at the same time. Typically produce a couple quadrangle maps per year.

EDMAP - program for universities to get undergrads in the field and get mapping experience. Maps available as PDF and shapefiles.

Applications (derivative mapping) STATEMAP doesn't pay, but sometimes can get it done.
